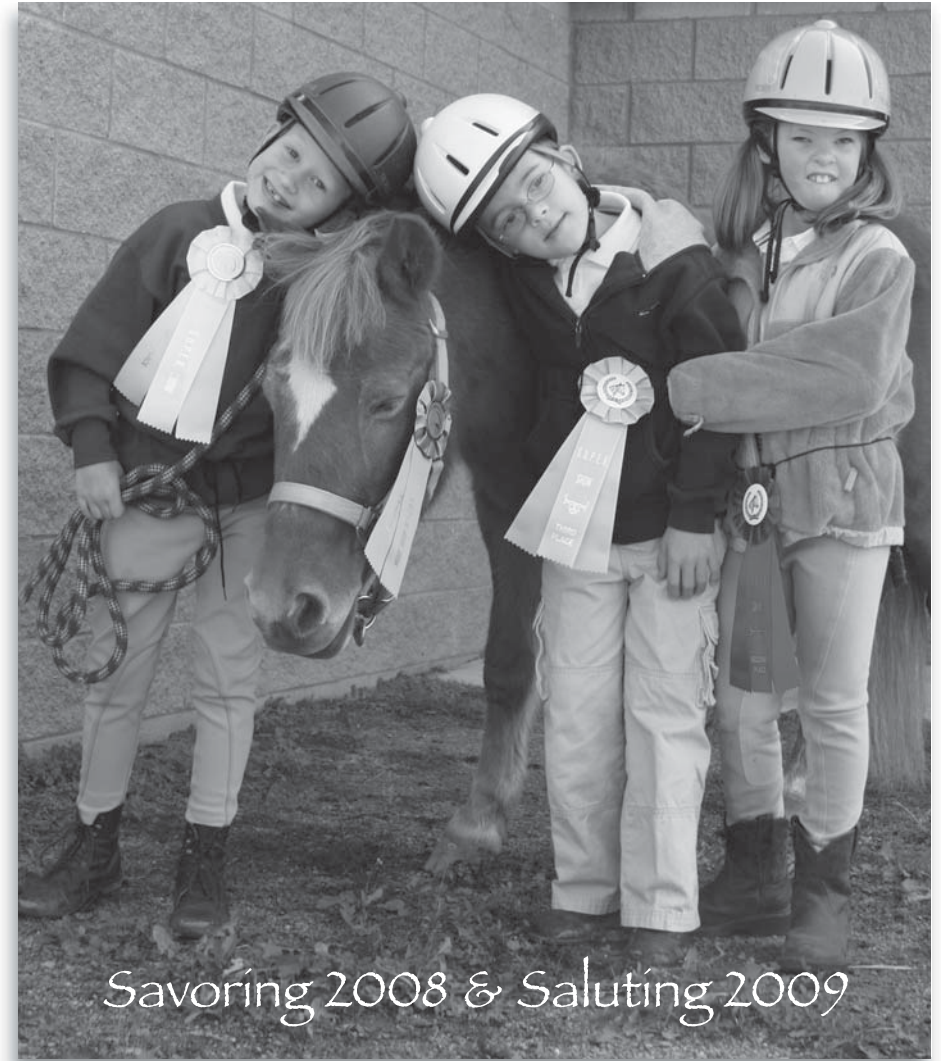
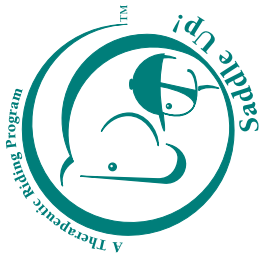

Facing the challenges of 2009 and the many ways YOU can help



Little Bits

As 2009 begins, the sagging economy is the elephant standing in everyone's living room, and Saddle Up! is no exception.

We know that 2009 will be challenging. At the same time, we are optimistic that – with your involvement and support – we will rise to the challenge. After all, every challenge contains at least a seed of opportunity, so we'll be carefully looking for that seed (or many seeds), planting it, and nurturing it as the year goes on.

Thanks to our Board's leadership, we have begun the year in a financially responsible and conservative position. We have reduced our budget 5% compared to the 2008 budget, and we'll be monitoring monthly to ensure that we are on track or, even better, ahead of it. We'll also be scrutinizing even more closely every penny, nickel, dime and dollar used for expenses. I frequently share that Saddle Up! is the only place I've ever seen where the hallway lights are normally left off in the office area, unless it's an extremely gray day or dark, because we don't want to spend the money for lighting. Frugality is also why we have lights for the indoor arena marked for each day of the week,

so that we use only those needed instead of lighting everything. All those little things do add up!

In addition to reducing our budget, we have decreased the number of riders served weekly, a decision that was wrenching but necessary. In 2008, we had a huge increase in the number of riders served and lessons. We started 2008 with 107 weekly participants and, for the fall session, we had 136 weekly participants. Stewardship required that we set a maximum of 120 a week for 2009. Continuing at 136 would have required additional staff – horses and human – and more volunteers, and in today's climate that was not the most prudent course of action.

We are continuing our Waitlist Provisional Riders program to make sure that children and youth on our waiting list have the opportunity to experience some of the benefits of riding or nonmounted lessons as they wait for a regular spot in the program. Because we don't have as many Waitlist spots available in lessons, we are dividing our 16-week sessions into two sessions for the Waitlist participants. That means we will be able to serve almost twice as many as if we had the Waitlist participants ride for the

entire session. We'll also continue to offer summer lessons to our Waitlist children. With more than 260 children on the waiting list, that is important.

One thing we did not do: increase the fees for lessons. As most of you know, we charge \$15 a lesson, and we offer scholarships for those families needing help. The fee is among the lowest in the nation, and it covers about one-tenth of the \$150 it costs to put a child on a horse. We may reach a point where we have to raise fees, but,

especially with the current economic challenges, we did not want to increase the financial burden of our participating families at this time.

Though the economy is challenging, we have so many, many positives going for us at Saddle Up! – a great Board, a strong core of committed volunteers, our donors and funders, our families, and a staff team that is unbeatable. These, and more, are the reasons for our optimism. So, how can you make a difference? Here are a couple of possibilities: **★ Donate to the annual fund campaign.** This campaign provides funding for everything we do at Saddle Up!. It is essential to bringing our mission to life. And it's easy to do! We've included a

Volunteers founded Saddle Up!, grew it from the germ of an idea to one of the largest centers in the nation, and continue to serve in all capacities. Quite bluntly, we can not do this program without volunteers. We always, always need volunteers, so please visit the website to learn more about specific opportunities and then enroll in training.

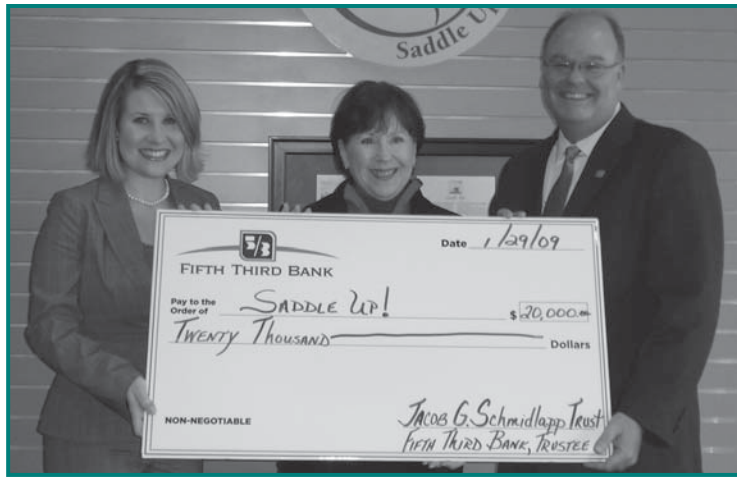
Together, we can continue to provide this special program to the children we serve and make sure that Saddle Up! remains the place, “Where all children are equal in the saddle.”

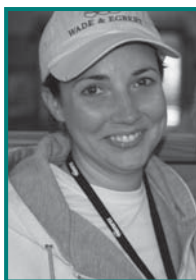

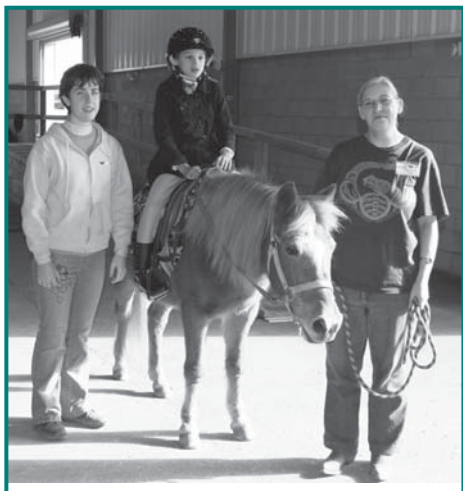

Staff increase knowledge at NARHA conferences

The conferences provide a prime opportunity for staff to increase knowledge about equine assisted programs, including teaching techniques, research in the field, administration/management, horse care and more. After the conferences, staff shared

the key information they had gained and discussed how to put it to work at Saddle Up!. Participants included 13 Instructors.

Prior to the national conference in Connecticut, Instructors Lisa McKinless and Melissa Mosley participated in the first NARHA Mentor Training Workshop, designed to improve skills and programs for training NARHA Instructor candidates. Both Lisa and Melissa earned certifications as Mentors. Saddle Up! has an ongoing Instructor-in-Training program to develop new Instructors

for the program, and it will benefit from the knowledge and skills Lisa and Melissa have gained.

Melissa and NARHA Certified Instructor Kelly Sheehan received scholarships from NARHA for the national conference.

Did you know all NARHA Certified Instructors must have a minimum of 20 continuing education hours and remain current in CPR and First Aid training each year in order to maintain their certification?
